4. FIRST AID MEASURES

First aid measures

6. ACCIDENTAL RELEASE MEASURES

Due to the organic solvents content of the preparation:

- Personal precautions** : Exclude sources of ignition and ventilate the area. Avoid breathing vapor or spray. Refer to protective measures listed in sections 7 and 8.

7. HANDLING AND STORAGE

- Handling** : Due to the organic solvents content of the preparation: Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapors in air and avoid vapor concentrations higher than the occupational exposure limits. In addition, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard. Keep container tightly closed. Keep away from heat, sparks and flame. No sparking tools should be used.
